## WHAT IS MAINE'S PERCENT FOR ART PROGRAM?


In 1971 a law was established that decrees 1% minimum of the budget for construction or renovation costs of buildings funded through Maine taxpayer dollars will be appropriated for acquiring works of art. The law also declared that the MAC was to develop and administer this program.



Artwork budgets have ranged from \$3,000 to \$150,000 depending on the size of the construction budget. On average they are around \$50,000 (schools).

## PFA BASIC PROCESS...

### Takes on average one year to complete!

Project budget is established.

A selection committee is appointed and makes the decisions regarding the type of selection process and details of Call For.

Call marketed and applications collected.

Committee reviews and scores applications based on specific criteria. Finalists are chosen.

Finalists give presentations (paid).

Selection committee makes final recommendations of artist/s, locations, artwork, and budget allocation.

MAC and Site give final approval of the process/work.

Artist/s receives contract from contracting agency to start. (Not MAC)

- 1. Resume
- 2. One-page written proposal
- 3. Itemized budget
- 4. Maintenance plan
- 5. Five digital images of your work

# SUGGESTIONS FOR MAKING A STRONG PFA APPLICATION




1. Read the Call For carefully. Especially the "BACKGROUND" section. LOOK FOR KEY PHRASES! These should inspire and be the key ideas that your design will symbolize.

#### **EXAMPLE:**

Central Community Elementary School is located in Corinth Maine will unite students from five surrounding towns. Each tight knit town has its own distinct culture and history that contributes to the character of this rural region. Preservation of these histories is paramount as the region transitions from operating five elementary schools, to operating one. While each town is unique, they do share some commonalities. The region consists largely of farmland. Popular pass times include outdoor recreation such as hunting, 4-wheeling, and fishing. Each town has its own body of water and ample numbers of nature trails, making it ideal for its outdoor loving residents.

2. Carefully Consider the proposed locations. Do any of them make more sense for your work? Exterior? Interior? Both? TRY TO GO SEE THEM IF POSSIBLE!



### 3. YOUR RESUME-

- Should reflect ANY type of public art or commissions that you or your work have been a part of
- A strong showing of exhibitions or commissions (active in your field)
- Any projects that you were successful at managing and completing
- Your current contact information!!

### 4. THE ONE-PAGE PROPOSAL NEEDS TO INCLUDE:

- Briefly describe your work My work focuses on ...
- Discuss your broad concepts for the project
   For this project I will create pieces that reflect
   the ideas/ themes of ...(inspired by the background
   section)
- Explain how those themes will be visualized in your designs
  - The theme of "rivers" will be incorporated into the patterns of the ...
- Discuss the details of proposed work for EACH location I am proposing to install three hanging light sculptures in location #2....

# 5. THE BUDGET (by proposed location/s)

Provide an itemized budget that includes the following costs:

- Artist fees (yes, pay yourself!)
- Fabrication/production
- Transportation
- Documentation
- Installation expenses

Committees like options and this is where you can offer them choices. Included in your budget, you can list each location your proposing and the budget amount for each. You can slice and dice it anyway you want.

In the end the selection committee can chose as many artists/works/locations as they want for the overall PFA budget!

# **BUDGET** example

My budget for the Sally School PFA project is \$33,000. It includes 10 framed paintings total for locations 1, 2 and 4.

```
(itemize the whole amount for $33,000) 21,000 artist/production fees 5,000 frame fabrication 4,000 materials 1,000 transportation 2,000 for install and documentation
```

Location 1 – 5 paintings at 40" x 40" for \$15,000 (plus transport, install and doc)

Location 2 – 3 paintings at 40" x 40" for \$9,000 (plus transport, install and doc)

Location 4 – 2 paintings as 40" x 40" for \$6,000 (plus transport, install and doc)

# 6. Maintenance Plan

This can be brief but be honest! The contracting agency has ownership of your piece once it is installed. It is their responsibility to keep in it good condition. Caretakers will most likely be staff from the facilities department so be detailed and help them out! (two sentences usually)

# 7. IMAGES OF WORK

One of the most important parts! Let your work really speak for itself by using quality images.

Committee members will be reviewing the applications online. So if it looks great on your monitor, chances are it's going to look good on theirs too!

No real standard for sizes of images (pixels etc), only that the FILE size does not exceed what you can upload into the GMS (50 MB max).

### **EVALUATION CRITERIA FOR PFA PROPOSALS**

- Artistic strength as shown through vision, originality, and understanding of craft (30 points). (images, resume)
- Ability to translate artistic concepts into work that will activate or enhance the proposed space (25 points). (design of work in proposed locations)
- Application is comprehensive in information and ideas are well communicated (20 points). (write simply and clear. Not everyone on the selection committee has an arts background)
- Ability to design work that is sensitive to social, environmental, historical, and/or other relevant contexts (15 points). (this is where they KNOW if you really read the background section)
- Capacity to complete the proposal on time and within budget (10 points). (resume, proposal, budget)



## STATS AND SHAREABLES



- Maine is 1 of 28 states in the US that have a percent for art program
- •Since 1982, Maine's Percent for Art Program has generated approximately eight million in funds for public art in Maine
- More than 475 projects
- It has employed approximately 850 artists
- Percent for Art is truly represented statewide, placed in 175 communities across all 16 counties
- Approximately 900 works of art
- Currently 22 projects listed from now 2021
