Broadband for Island and Coastal Sustainability Planning Grant

Island Institute is proud to offer Broadband Planning Grants, through the Tom Glenn Community Impact Fund, to support community-driven broadband projects in Maine's coastal and island communities. High-speed, reliable internet service is essential, to ensure equitable access to education and healthcare, to support civic engagement and aging in place, and to spur economic diversification and prosperity.

Who is eligible?

We encourage applications from local or regional broadband working groups of Maine coastal and island communities that are in regular communication with Broadband staff of the Island Institute. Recipients of planning grant funds must be a Maine municipality, local institution, or nonprofit.

What is the size of the grants?

The amount of a grant may range from \$5,000 to \$15,000. An application for a grant serving a large region of communities may request a larger amount. Matching funds are required, and any application with an amount requested that is more than \$15,000, or without a 1:1 match, will be considered only if significant need and impact is demonstrated. Neither grant nor matching funds may be used to procure services that would otherwise be provided by the Island Institute free of charge to the applicant, broadband working group, or their community.

How and when do I apply?

With a Broadband Planning Grant application form, the applicant will demonstrate how the grant will be used to overcome barriers to establishing or expanding broadband infrastructure. Island Institute welcomes applications on a rolling basis. Please submit the application electronically (see top of the page). A report on how funds were used is required at the completion of the work, and if applicable also one year from the award date.
